STEAMlab is a cutting-edge, high-tech educational space for children ages 6 and above, including adults offering experiential, project-based learning programs in coding, robotics, engineering, laser cutting, soldering and 2D/3D design. In 2022, STEAMlab reached more than 5,500 children and adults through scheduled programs, targeted outreach and standards aligned lessons through schools. New programs started in 2021 include Girls Who Code and Teen Tech Squad, each afterschool program met full capacity and additional sessions were added. A STEAMmachine Task Force was formed to build out a mobile STEAMlab to reach underserved rural communities in the 2023 - 2024 school year.
